**SCHEDULE OF FEES FOR GRANT OF ARMORIAL BEARINGS<sup>2</sup>**

**Processing Fee**

Each project to create heraldic emblems requires payment of a non-refundable processing fee of **\$250** once eligibility to receive a Grant of Arms has been determined by the Chief of Honour. Petitioner will receive an invoice for this fee, which applies to the total fees. Upon acceptance of the Petitioner’s application and determination of total fees by the Honours Office, **50% of the total is due and payable before beginning the process.**

**Design of Armorial Bearings**

Includes digital design, minor revisions, a coloured design for review. Petitioner understands that all artwork produced by the Ethiopian Crown Honours Office for new Armorial Grants will be rendered digitally using vector art, flat-coloured in traditional heraldic tinctures only (**Azure, Gules, Sable, Vert, Purple**) and metals (**Argent, Or**). The Petitioner may opt to have their Achievement rendered by an artist of their choice, but such commissioned work must adhere to the specific format and layout as developed by this Office. **Prices are in US dollars and are subject to change without notice.**

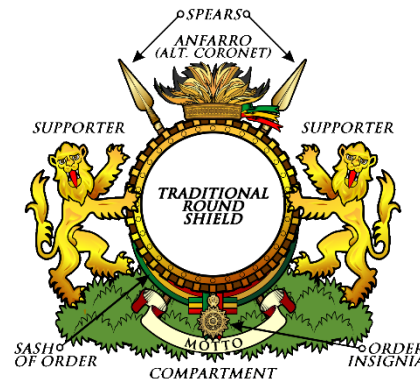
